**Sub: Urgent Request for Resolution of Water Supply and Infrastructure Issues in Vasant Kunj Society**

Dear Sir,

We trust this letter finds you well. We the residents/owners of DDA Flats, Sector E-1, Vasant Kunj (Society), have invested significantly in our flats with the expectation that our society, named Vasant Kunj, would provide a quality living experience.

Regrettably, we are facing persistent challenges, with one of the major issues being an inadequate water supply. Despite regularly paying our water bills to DDA, we often encounter disruptions in our water supply, with some towers experiencing water shortages for entire days due to fluctuations in the supply of water tankers. We believe that, as homeowners, we are entitled to a reliable and approved daily water supply without fail.

Furthermore, we wish to draw your attention to the substantial damage caused by the movement of heavy water tankers within our society. This has led to numerous potholes on the main roads, breakage of drain covers, pavements, railings, and walls, which unfortunately remain unrepaired for an extended period. Attached to this letter are images illustrating some of these damages for your reference. These images are self-explanatory, highlighting the severity of the damages. It is not far-fetched to anticipate that these issues might soon pose a risk of injury to children, senior citizen, or damage to individuals' property.

Considering that these main roads of our sector falls within the purview of DDA, we earnestly request your prompt intervention to address and repair the damages at the earliest. To prevent the recurrence of such issues, we propose the operationalization of an underground water pipeline extending from society's gate no. 2 to the underground reservoir (UGR) of the society. This pipeline would facilitate water supply to the society's UGR from the main road at gate no. 2 without the need for water tankers to enter the society. The delivery process through this pipeline could be streamlined using a motor for efficient water transfer. This measure would not only save time for the tankers but also increase the frequency of their rounds, ultimately resulting in improved and consistent water supply. Importantly, it would prevent further damage to our society's infrastructure caused by the movement of heavy tankers.
