Sub: Request for construction of curve at the junction of the Mehrauli-Mahipalpur and E1- E2 Sector Road.

Dear Sir,

The Gate No 1 of the E 1 Vasant Kunj Society is closed due to construction of the Mahipalpur Metro Station of the DMRC and the residents have the only option to use the Road between Sectors E 1 and E 2, Vasant Kunj to connect with the Mehrauli-Mahipalpur Road. The completion of the Metro work is going to take quite a lot of time and, therefore, we write to your good self for construction of curve at the junction of the Mehrauli-Mahipalpur and E1- E2 Sector Road, which is required even irrespective of the additional traffic congestion resulting due to closure of the Gate No 1 of the E 1 Vasant Kunj Society.

The Road between the E 1 and E 2 Societies remains highly congested as it has to take much higher traffic load than it is meant for. The perennial congestion on the Road has been cause of multiple problems like the school children getting late for schools, office goers getting late for offices, environment getting excessively polluted and the aged and the sick facing rise in frequency of aggravation of their ailment. Even the Hon'ble NGT and DPCC have acknowledged the problem of congestion and the complications it is leading to.

In this context the E 1 Vasant Kunj RWA would like to request you to construct a curve / small slip at the junction of the Mahipalpur-Mehrauli Road and the E 1- E 2 Road in a manner that the traffic moving from the said E 1- E 2 Road towards Mahipalpur and from Mehrauli-Mahipalpur Road towards E 1 Society wheels freely on the respective roads.

Further, since the E 1-E 2 Road is not meant for heavy vehicles, it is requested to install a height barrier at the end of the two Sectors.

An early solution will lend a big relief to the residents of the two societies.
