NUISSANCE DUE TO HIGH NOISE POLLUTION : CNG STATION MAHIPALPUR

Dear Sir,

I represent the residents of DDA Society, E1 Sector, Vasant Kunj, New Delhi-110070 in capacity of President, Resident Welfare Association (RWA). May I take this opportunity to highlight some problems created by one of your CNG stations (Filling Station) located on the following address:

CNG Station Mahipalpur
Mata Chowk, Vasant Kunj - Mahipalpur Road
Mahipalpur, New Delhi -110037.

2. The above CNG Station has become a cause of concern due to extremely high noise pollution caused by its recently installed compressors and a perpetual brawl between staff and customers. The compressors flout all norms of permissible limits of noise and are louder than any loudest DJ system. These run almost continuously for 16-18 hours in a day with brief breaks. Moreover, they have been located right next to the boundary of the Society with dwelling units of residents as close as 20 meters. The compressors either do not have noise mufflers or they have not been installed correctly thus causing deafening levels of noise pollution. This combined with loud verbal brawls between staff and customers has made life in Society extremely difficult.

3. The compressors have been placed right next to the Society wall and dwelling units, in spite of adequate space available to the CNG Station with utter disregard to safety norms. May be a correct location could have avoided this problem. All these issues have agitated the residents and merit immediate attention.

(a) Instruct the concerned agency or staff to take immediate remedial measures to bring down the noise pollution levels by either by shifting the compressors away from Society/dwelling units or incorporating technology that may bring down noise levels radically.

(b) Issue necessary instructions to your staff at the CNG station for better professional conduct.

5. The final solution to the problem lies in shifting the CNG station away from residential area at any other suitable location. Till then the measures given above will assist to diffuse the situation.

6. We have always considered IGL to be a responsible corporate which has contributed immensely to control the air and noise pollution levels in NCR. I am sure you will be able to act equally effectively and urgently to address this acute problem and health hazard, faced by residents perpetually on daily basis.
