Dear Sir,

The E 1 Vasant Kunj Society houses 1214 flats. The occupancy percentage in the Society is very high and so is the Property tax compliance by the flat owners.

It is regretted to say that the Society has not been getting any service from the corporation in spite of property tax payments by the flat owners.

The Society is faced with multiple problems due to dirty, unhygienic conditions of roads and absence of waste collection services from the Corporation. No awareness camps in respect of any of the several innovative initiatives, like Zero waste policy and geo tagging of properties, of the Corporation have been organised in the Society.

It is learnt that the process of handing over of the common areas of the Society by DDA to the Corporation is underway. We urge that provision of services to the Society should not be linked to handing over as the property tax collections from the Society are being done by the Corporation for last four years.

In view of the above, it is requested to start provision of the following services to the E 1 Vasant Kunj Society immediately:

- 1. Sweeping of the society roads.
- 2. Waste collection.
- 3. Holding awareness camps in respect of better provision of Civic Services in the society.
- 4. Holding awareness and sensitisation camps on stray dogs management in the society.
- 5. Cleaning of drainages which are heavily choked.
- 6. Any other services in the scope of the Corporation.
