This is in continuation of our communication No...32 .dated 17 th January (copy attached with this mail) addressed to the Director, Veterinary Services, MCD, vide which incidents of dog bites in E 1 Vasant Kunj Society were reported and request for remedial measures were made.

It is regretted to say that no effective steps to bring the situation under control have been taken from your end.

Now we write to you to inform that the rate of incidents of attacks and bites has increased so much that the maids of our society struck work today and staged a protest at the gate of our Society against such incidents. Police had to be called to keep the situation in control.

Photos and videos of the incident are attached. Also attached to this email, is the list of victims along with their medical documents, highlighting the severity of the situation.

A reference is invited to the SOP issued vide No 3-4/2021-22/PCA dated 29.11.2022 by the Ministry of Fisheries, Animal Husbandry and Dairying, for dealing with such incidents and It is requested to take necessary action to remedy the situation so as to prevent occurrence of the incidents of attacks and bites in the society in future.
