Sub: Request for refund of charges in respect of electricity consumption of Bore wells in E 1 Vasant Kunj Society, paid from the RWA and OTM funds and for resolution of other grievances raised by RWA from time to time.

Dear Sir,

This is in continuation of our above communications wherein the circumstances leading to a huge amount in respect of the Common Area and Lifts Electricity Consumption due to the reasons attributable to DDA were enumerated and it was intimated that the RWA decided to make payment in respect of the outstanding amount for one of the Blocks, under protest and without prejudice to our right to proper resolution of our grievances. As informed vide the above-mentioned communications, the Electricity supply to Bore wells had been taken by DDA from the Common Areas and Lifts Electricity connections which resulted in the charges in respect of electricity consumption of Bore wells in E 1 Vasant Kunj Society, getting billed against the Society. Accordingly, a substantial amount of the payments made by the RWA from its funds and by DDA from OTM funds belong to the liability of the DDA (as the charges in respect of electricity consumption of Bore wells).

In view of the above, it is requested to reimburse to the RWA, E 1 Vasant Kunj Society the amounts of charges in respect of electricity consumption of Bore wells, the payment of which has been made by RWA from its funds and by DDA from the OTM fund early, please.

Further, the DDA part in the outstanding/unpaid bills, on account of the electricity consumption of the 3 Bore Wells connected to the A Block Common Area and Lift Electricity connections (up to 09 February 2024) and 1 Bore Well connected to the D block connection even up to date, needs to be contributed by the DDA immediately, to enable the RWA to make payment without delay and save the eventuality of disconnection of the supply by the BSES.

It is also requested to resolve all the pending grievances raised by the RWA vide the above-mentioned and earlier communications.
