Sub.: Request to allow time for making payment in respect of Bills pertaining to Common Area & Lift Electricity Connections of DDA Flats, Sector E-1, Vasant Kunj, New Delhi-110070 (Society).

Dear Sir,

Our subject mentioned Society has 06 BSES connections (CA No. 153326470, 153326478, 153326479, 153326476, 153326472 and 351028933) for the Common Area & Lift Electricity supply. All 6 connections are in the name of the Executive Engineer (Elect.), DDA Elect. Div-6. The payment in respect of the Bills of the said connections was being made by DDA and now the liability has been transferred to the RWA of the Society.

In relation to the aforementioned liability of RWA, we hereby present some facts and requests before you:

1. In a gesture of sincerity and in the interest of continuity of uninterrupted supply to the residents, as also to facilitate DDA to get the connection transferred in the name of the Society, the RWA has made payments in respect of the entire outstanding Bill for B Block of the Society, (CA No. 153326478), as on the date of payment, thereby demonstrating its sincerity in assuming the responsibility for the payments.
2. As regards payment in respect of other blocks, a certain part of the pending Common Area & Lift Electricity Bill is payable by DDA on account of the Electricity supply for 04 Bore Wells having been taken by DDA from the Common Areas & Lifts Electricity connections of the society. 03 of the 04 said Bore Well connections have now been shifted by the DDA to its own points.
3. A request for payment of its part of the Bills, transfer of connection from DDA's to Society, and getting the temporary /commercial connection converted into the domestic one has also been made to DDA. A copy of the letter No 47 dated 19.02.24 is enclosed.
4. A positive response is expected from DDA soon.
