Sub: 1. Request for providing up-to-date details of One Time Maintenance Fund amount collected from the allottees of the E1, Vasant Kunj Near Sultan Garhi Tomb, Mehrauli Mahipalpur Road, New Delhi-110070 and interest accrued thereon till date.

2. Request for the format of the Agreement to be entered into for opening and operating the Escrow Account.

Madam/sir,

The DDA collected contributions from all the allottees of the flats of the Society as per the DDA Housing Scheme 2019, towards the maintenance fund for the purpose of major (capital nature) maintenance, for 10 (ten) years. The Scheme requires that the entire maintenance funds collected would be placed in a corpus as an escrow account and maintenance works (Capital nature) would be undertaken out of the interest earned from the corpus.

However, DDA has not provided the details of:

- i. The total amount of the maintenance fund collected by the DDA from all the allottees of the flats of the Society,
- ii. The amount of the interest accrued on the said fund till date,
- iii. The total amount of the expenditure, if any, incurred by the DDA from the said fund till date,
- iv. The total amount of the corpus/principal in the fund as of date and
- v. The total amount of the interest component in the Fund as of date, to the RWA.

The representatives of the Association have been requesting the concerned DDA authorities for the above-mentioned details for quite some time to decide the works which the RWA can recommend and get carried out on priority but the same has not been provided so far with the result that several important and urgent works are getting delayed and condition of the society is deteriorating day by day.

It is, therefore, requested to provide the above-mentioned details to the RWA on priority please.

Further, the RWA provided all the necessary details and documents required for opening the Escrow Account long back. However, there is a delay on DDA's part with the result that the account has not been opened so far.
