With reference to your above cited letter, it is to inform that for taking a decision in respect of the works to be got carried out in the Society from the interest accrued on the One Time Maintenance Deposit, the RWA requires the following details from DDA:

A:

- 1.The total amount of the maintenance fund collected by the DDA from all the allottees of the flats of the Society,
2. The amount of the interest accrued on the said fund till date,
3. The total amount of the expenditure, if any, incurred by the DDA from the said fund or the interest component, till date,
4. The total amount of the corpus/principal in the fund as of date and the total amount of the interest component in the Fund as of date.
